Data Priorities



- ▶ For recommendations to RPB
- Data WG completed initial inventory of data priorities
- Developed assessment framework to determine themes with highest priority for synthesis
- Seeking feedback on assessment framework and synthesis priorities.

Data Priorities



Status	Action
Adequate Data (in WCODP)	No Action
Adequate Data (not in WCODP)	Priority catalog connection
Adequate inputs (regional, accessible, geospatial)	High priority for synthesis
Inadequate inputs (not fully regional, non geospatial, not accessible, or no data)	Lower priority for synthesis
No data	Communicate priority to network, RPB, WCOP

Data Priorities



- Many themes have adequate data from other sources – priority for catalog connections
- ► Biological themes relating to seabird, fish, invertebrate richness high priority for synthesis
