- Usefulness of West Coast Wide Jurisdictional Map (WA State as pilot)

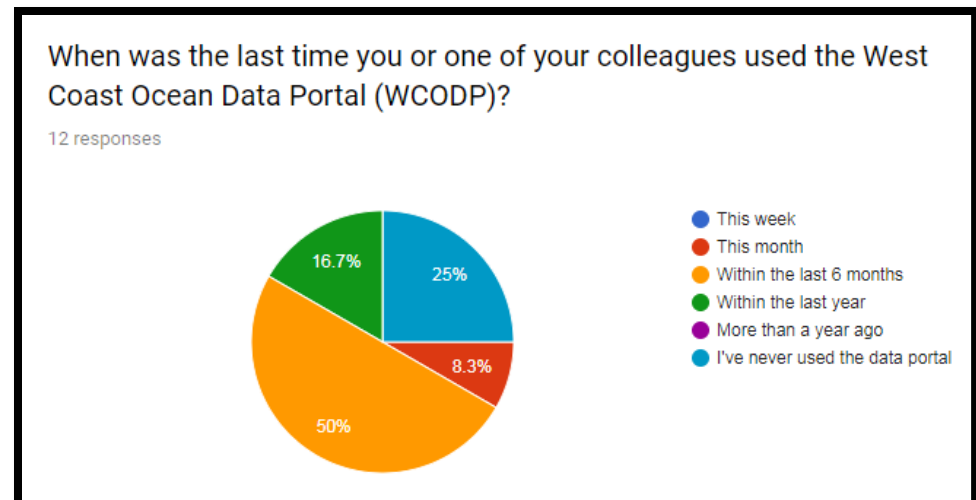
